To Schools served by OhioGuidestone's School-Based Mental Health and Support Services:

We want you to know OhioGuidestone is committed to continuing our mission to serve the youth, adults, families and communities that need us especially during a time of heightened community stress and anxiety. During this unprecedented time, our therapists and community mental health workers will continue mental health services to the students and families we serve through telephone and video conferencing only. Home visits are no longer permitted for the safety of all, with only a few exceptions for critical/crisis clients. We understand that during this transition, students and families may well need continued support. Please know we are available for anything you may need to support your staff, students and families. Refer to list below for contact information.

OhioGuidestone staff are available during this time through the following avenues:

- Tele-health – OhioGuidestone will be offering Tele-health as an alternative to in-person counseling services. Tele-health increases access to care by overcoming barriers to services, such as access to reliable transportation, scheduling conflicts, needing to take time off work, and in this time the need for social distancing, etc. Tele-health services use online videoconferencing technology, much like Skype or FaceTime, to connect individuals to the help they need – anytime, anywhere.
